CE/CLE FAQs for Live Webinars



Doma Title Insurance, Inc. regularly hosts live continuing education (CE) and continuing legal education (CLE) webinars for title insurance agents and attorneys.

Agents and approved attorneys of Doma Title Insurance are eligible to receive CE and CLE credits by participating in these online programs. Below is a list of frequently asked questions, which includes details on how to qualify for credit.

Q: How do I know if a course has been approved for CE/CLE credits in my state?

A: The list of states that have been approved for a course are available on the registration and information page for every webinar, as well as on the course listing page, found at

https://www.doma.com/events/. You may view all of our educational events and their list of approved credits at that web address at any time. Course approval status is updated on a regular basis, but if you have any questions, please feel free to contact our staff at education@doma.com.

Q: What is the cost to attend a Doma webinar?

A: There is no cost to attend our webinars, which are open to the public. CE/CLE credit is also granted at no cost to Doma agents and approved attorneys as part of their exclusive underwriter partnership benefits.

Q: I am not a Doma agent or approved attorney. Can I still earn CE/CLE credit?

A: CE/CLE credit is available only to active Doma Title Insurance agents, approved attorneys and their employees. To learn more about joining our network, email **join@doma.com**. You will be contacted by a local agency manager.

Q: What is the length of your webinars?

A: Our webinars are typically 70 minutes long, and we offer 1 hour of CE/CLE credit to Doma agents and approved attorneys who meet all attendee requirements.



Q: How do I earn my credits?

A: For agents and approved attorneys in all states where we offer credit, you must complete the following requirements:

1. Be sure to include your license number (or bar association number) when you register. We cannot submit credit for you without this information.

2. Register for yourself, and attend the webinar using your individual registration. Stay logged on and attentive (our platform monitors your individual log-in and activity) for the full duration of the webinar, on a separate computer from other participants.

3. Respond to three random attendance check prompts. These prompts will appear on your screen approximately every 20 minutes, and request that you acknowledge you are still logged on and attentive. Our webinar platform documents your responses.

4. Complete a webinar evaluation at the end of the event, which will pop up on your screen when the webinar ends. You will also receive a link to the evaluation in a follow-up email after the webinar.

Q: May I earn credit in multiple states?

A: Yes. You may earn credit in any of our approved states where you hold a license. Be sure to include all of your licenses/bar association numbers on your registration.

Q: I arrived late to the webinar. Can I still obtain credit?

A: You must be logged on and attentive for the full duration of the live webinar (usually 70 minutes) in order to obtain credit.

Q: I missed an attendance check prompt. Can I still obtain credit?

A: You must respond to all attendance check prompts in order to obtain credit.

Please ensure that pop-up windows are enabled on your computer/device prior to the webinar.

Q: I encountered technical difficulties in attempting to respond to an attendance check prompt or take the evaluation. How does this affect my credit?

A: If you experience technical difficulties during the attendance check prompt, sending a message to our moderator during the webinar through the Q&A box indicating you are present and attentive will suffice. The evaluation will be available in a follow-up message in the event you miss taking that at the end of the webinar. Please contact our staff for assistance in dealing with these matters at **education@doma.com**. We will address each individual situation and help you obtain credit if we can.

Q: When can I expect to receive my credit?

A: Credit submissions will occur within two weeks following the webinar. We will email certificates of completion within three weeks, after credits are successfully submitted. If you are in a selfreporting state, the course number will be included on your certificate of completion.

Q: I see that you record and upload your webinars to Doma Academy. Can I retake a webinar I attended live for credit again?

A: No. Doma Academy, our on-demand education platform, offers a variety of webinars, both for CE/ CLE credit and informational purposes.
